Stonycreek-Conemaugh River Improvement Project

North Fork of Bens Creek Coldwater Conservation Plan *by Len Lichvar*

The North Fork of Bens Creek in Somerset County is a small 12.8 square mile watershed tucked away on the east face of Laurel Mountain. Despite its remoteness is really only a few miles removed for urban centers and possesses some of the finest water quality in the entire region.

The Somerset Conservation District realized that there was never an in depth study of this watershed undertaken. In order to remedy that, the District requested and received a Cold Water Heritage Partnership (CHP) grant to create a Coldwater Conservation Plan for the watershed. The CHP is a partnership of

the Foundation for Pennsylvania Watersheds, the Pennsylvania Fish and Boat Commission (PFBC) and the Pennsylvania Department of Conservation and Natural Resources that focuses on the unimpaired waters in the state in order to create methods to maintain their water quality.

The North Fork encompasses 26 stream miles that ultimately meet the South Fork of Bens Creek to form the mainstem of Bens Creek, an important tributary to the Stonycreek River. Major tributaries to the North Fork are Alwines Creek, Riffle Run and Heckman Hollow. *(cont. page 2)*

AMR Deadline June 23

“**Collaboration is Essential**” is theme of this year’s Abandoned Mine Reclamation Conference to be held at the Ramada Inn and Conference Center in State College, PA. The cost is \$40 for members of non-profit conservation organizations and scholarships are available to offset lodging. Registration deadline is June 23. The watershed also included the North Fork Reservoir owned and operated by the Greater Johnstown Water Authority (GLWA).

The stream above the reservoir has been designated by the Pennsylvania Department of Environmental Protection as Exceptional Value (EV) which means they meet the highest water quality standard in the state. Not surprisingly populations of wild trout also inhabit their headwaters.

The lower reaches of the North Fork are designated High Quality Cold-water Fishery and also contain wild trout even as they flow through a golf course and residential areas.

District Watershed Specialist Greg Shustrick, who authored the plan, along with the assistance of the GJWA, PFBC and the Mountain Laurel Chapter of Trout Unlimited gathered extensive data on the watershed.

Sampling of aquatic life indicated a tremendous diverse community of aquatic insects confirming the extremely high quality of water present.

Electro fish surveys, conducted by the PFBC and the District, indicated that the wild trout population has increased over the years providing further evidence of the consistently outstanding water quality.

The Plan also indicated potential threats to the water quality such as sedimentation from unimproved roads, nutrient loading from agriculture lands, manicured lawns, failing septic systems and removal of forest canopy.

To minimize these and other impacts in order to maintain rather than degrade the watershed, the Plan also describes a full allotment of conservation recommendations

that if implemented will secure the water quality of the watershed for the future.

Many of our regions downstream waterways have suffered degradation by man made intrusions. Although much work, money and effort has gone into improving those waterways, those efforts would be compromised if our best upstream water quality is negatively impacted.

The Plan is designed to provide decision makers with the scientific data and information to balance resource conservation against further development pressures in order that economic benefits can be derived from both.

SCRIP \$500 Scholarship

The Stonycreek Conemaugh River Improvement Project will be awarding a \$500 Scholarship to a worthy student for the 2014-2015 academic year. Deadline to submit is August 1, 2014.

Eligibility—Applicant must:

Either be a dues-paying SCRIP member or the child of a SCRIP member

Reside in Cambria or Somerset County

Be at least a college sophomore and in an environmental field of study at a Pennsylvania college or university.

How to Apply:

The application should contain these three parts:

Part I- A cover sheet with the following information: name, mailing address, email address, phone number, college or university attending, year and course of study

Part II- A typed statement, double-spaced, 12 pt font size, no longer than two pages explaining their professional goals, how their course of study will meet those goals and any involvement to date in the field.

Part III- A copy of their latest transcript

Applications must be received by August 1, 2014. Please send to: SCRIP, Scholarship 2014, P.O. Box 164, Windber, PA 15963. Award notification will be no later than August 30, 2014. Award check will be sent directly to the Financial Aid Office at the college or university.

Award recipient will be required to inform SCRIP of his or her personal academic achievements, graduation and future career plans in article form for publication in the SCRIP newsletter. This information will be used to assist with promotion of any future SCRIP scholarship awards.


He has worked in private industry as vice-president of Wilson Electric Pumps from 1985 to 1998 and with L. Robert
